### Composition and information on ingredients

Our Pure Madagascan Vanilla Extract is produced from Madagascan vanilla beans (*Vanilla Planifolia*) – 1 fold - soaked in alcohol (35%) with added raw cane sugar (max. 4%)

### First Aid Measures

<b>Inhalation</b>	Remove to fresh air and keep at rest. Obtain medical advice.

<b>Handling</b>	Maintain good occupational and personal hygiene. Avoid inhalation and contact with skin and eyes. and sources of ignition. It is preferable to store in cool condition between 5 and 20 C.
